ACCESSIBILITY FOR FEDERAL GOVERNMENT AGENCIES

Accessibility is an important requirement for Federal government agencies. Section 508 requires that all Information Technology (IT) systems, including Web sites, Web applications, software, and hardware, used, developed, procured, and maintained by Federal government agencies be accessible to people with disabilities. Failing to comply with Section 508 requirements can result in formal complaints being brought against non-compliant agencies.

ACCESSIBILITY REQUIREMENTS

Accessibility laws and policies affecting Federal government agencies include:

- **Section 508 of the Rehabilitation Act** – as amended in 1998 and enforced starting in 2001, Section 508 requires that all IT systems used, developed, procured, and maintained by the Federal government be accessible to people with disabilities.
- **Americans with Disabilities Act (ADA)** – the equal access requirement of the ADA requires IT system accessibility. Just as physical office locations must provide equal access for people with disabilities through ramps and elevators, similar accessibility enhancements are required for IT systems.
- **Other Requirements** – Section 504 of the Rehabilitation Act and Section 255 of the Telecommunications Act.

RELEVANT IT SYSTEMS

Under Section 508, all IT systems used, maintained, procured and deployed by U.S. Federal government agencies must be accessible, including:

- **Web Sites and Online Services** – Services that are offered on the Web, including online forms used to register for agency offerings, Web sites with information intended for public access, and customer service information, must be accessible.
- **Procured IT Systems** – All IT systems procured must comply with Section 508 regulations or the procuring agent and agency will face legal liabilities.
- **Internally Developed IT Systems** – IT systems such as Intranets, software applications, and hardware, must be accessible in order to avoid legal action by employees with disabilities.
